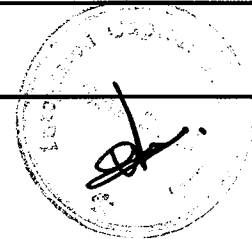

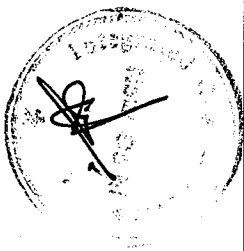

4 The Board of Directors of the Company had, in its meeting held on January 16, 2013, approved the merger of Investment Undertaking of Deora Associates Private Limited, Holding Company of the Company, which the latter was demerging. However, in view of certain issues connected with the scheme of demerger and merger in respect whereof sufficient clarity could not be obtained, the Board of Directors agreed for the current not to proceed with the aforesaid Scheme of Arrangement. In view of the foregoing decision of Board of Directors of the Company, the proposal for Scheme of Merger of Investment Undertaking of Deora Associates Private Limited with the Company, as approved on in-principle basis at the meeting of Board of Directors of the Company held on January 16, 2013, be considered as withdrawn.

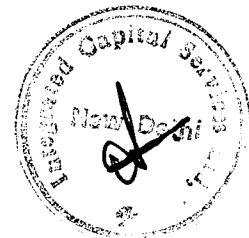
